



BAC RESOLUTION NO. 875-2021

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO DQT BUILDERS & SUPPLY FOR THE RE-BIDDING OF THE PROPOSED CONCRETING OF ROAD AND PARKING AREA FOR COT BUILDING IN THE AMOUNT OF P2,270,558.45

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Re-bidding of the Proposed Concreting of Road and Parking Area for COT Building* in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION SIX HUNDRED NINETY-NINE THOUSAND SEVEN HUNDRED EIGHTY-SEVEN PESOS AND 58/100 (P2,699,787.58) ONLY;

WHEREAS, in response to the said advertisement, five (5) prospective bidders acquired the bidding documents, namely: SCP Construction (SCP), Grand Alvatec Construction Corp. (Grand Alvatec), Davs Traders and Services (Davs Traders), DQT Builders & Supply (DQT Builders.) and Primax Konstruct, Inc. (Primax);

WHEREAS, during the deadline and submission of bids last December 13, 2021, 10:00 A.M., only Primax, Davs Traders and DQT Builders submitted their bid proposals. SCP and Grand Alvatec did not submit any bid proposals;

WHEREAS, the Committee then opened the first envelope of the prospective bidders in chronological order;

WHEREAS, Primax, Davs Traders and DQT Builders were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the BAC then immediately opened the second envelope of Primax, Davs Traders and DQT Builders;

WHEREAS, Primax made a bid of P2,500,672.77;

WHEREAS, Davs Traders made a bid of P2,429,808.78;

WHEREAS, DQT Builders made a bid of P2,375,923.18;

WHEREAS, the Committee considered the bids of Primax, Davs Traders and DQT Builders for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 14, 2021, 03:00 P.M. on the bids of Primax, Davs Traders and DQT Builders. The Committee found no minor arithmetical correction in the financial bid of Davs Traders. The amount of bid as read was the same as calculated. However, the Committee found minor arithmetical corrections in the financial bids of Primax and DQT Builders. The amount of bid as read was not the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated December 14, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Primax, Davs Traders and DQT Builders to be complying;

WHEREAS, DQT Builders was declared as the Lowest Calculated Bid (LCB) with an amount of P2,270,558.45;

WHEREAS, the Committee conducted post-qualification of DQT Builders on December 20, 2021;

WHEREAS, the Committee convened on December 22, 2021 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Mr. Danny Q. Tampan of DQT Builders was genuine, authentic, and responsive;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *DQT Builders & Supply* as the Lowest Calculated and Responsive Bid (LCRB) for the *Re-bidding of the Proposed Concreting of Road and Parking Area for COT Building*; and
- b) recommend the award of the contract to the said bidder in the total amount of TWO MILLION TWO HUNDRED SEVENTY THOUSAND FIVE HUNDRED FIFTY EIGHT PESOS AND 45/100 ONLY (P2,270,558.45);
