BAC RESOLUTION NO. 877-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO INFINIVAN, INC. OF THE RE-BIDDING OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS IN THE AMOUNT OF P1,400,000.04

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Re-bidding of the Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Internet Connectivity for USTP-CDO Campus* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION NINE HUNDRED THIRTY THOUSAND EIGHT HUNDRED PESOS AND 00/100 (P1,930,800.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: DCTech Microservices, Inc. (DCTech) and InfiniVAN, Inc. (InfiniVAN);

WHEREAS, during the deadline and submission of bids last August 30, 2022, 02:00 P.M., the same prospective bidders submitted their bid proposal;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, InfiniVAN was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, DCTech was rated "failed" due to the following ground: *The bidder's certification that it will provide technical support team during the duration of the lease of contract was not signed by the authorized representative;*

WHEREAS, the Committee informed DCTech that they may submit a motion for reconsideration within three (3) calendar days;

WHEREAS, the Committee then opened the second envelope of InfiniVAN;

WHEREAS, InfiniVAN made a bid of P1,400,000.00;

WHEREAS, the Committee considered the bid of InfiniVAN for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last August 31, 2022, 02:00 P.M. on the bid of InfiniVAN. The Committee found minor arithmetical correction in the financial bid of InfiniVAN. The amount of bid as read was not the same as calculated;

WHEREAS, in the Bid Form, there is discrepancy between the stated *total price per item and the unit price multiplied by the quantity of the item*. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3, "*In case of discrepancies between xxx (b) total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; and (c) stated total price and the actual sum of prices of component items, the latter shall prevail*". Therefore, the amount of bid as calculated is considered;

WHEREAS, the Technical Representative submitted a Technical Report dated August 31, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of InfiniVAN to be complying and declared InfiniVAN as the Single Calculated Bid (SCB) at the amount of P1,400,000.04;

WHEREAS, DCTech did not submit any request for reconsideration;

WHEREAS, the Committee conducted an on-site post-qualification of InfiniVAN at their branch office in 17/F Ore Central, 31st St. cor. 9th Ave., Fort Bonifacio, Taguig City on September 07, 2022;

WHEREAS, the Committee convened on September 12, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Ms. Seirril Anne S. Oblea of InfiniVAN was genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *InfiniVAN, Inc.* as Single Calculated and Responsive Bid (SCRB) for the *Re-bidding of the Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Internet Connectivity for USTP-CDO Campus*; and
- b) recommend the award of the contract in the total amount of **ONE MILLION FOUR HUNDRED THOUSAND PESOS AND 04/100 (P1,400,000.04) ONLY.**
