BAC RESOLUTION NO. 886-2021

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO DATAWORLD COMPUTER CENTER OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ICT EQUIPMENT FOR ALL-IN-ONE PRODUCTION STUDIO FOR THE PROJECT "LEARNING MANAGEMENT ENHANCEMENT AND ESTABLISHMENT OF 21ST CENTURY WEBINAR/SMART CLASSROOM" IN THE AMOUNT OF P20,998,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply, Delivery, Installation and Commissioning of ICT Equipment for All-In-One Production Studio for the Project "Learning Management Enhancement and Establishment of 21st Century Webinar/Smart Classroom"* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWENTY ONE MILLION FIVE HUNDRED SEVENTY SEVEN THOUSAND TWO HUNDRED PESOS AND 00/100 (P21,577,200.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Dataworld Computer Center (Dataworld) and AVLS All Visual & Lights Systems Corporation (AVLS);

WHEREAS, during the deadline and submission of bids last December 14, 2021, 09:30 A.M., the same prospective bidder submitted their bid proposals;

WHEREAS, the Committee then immediately opened the first envelope of the following prospective bidders in chronological order;

WHEREAS, Dataworld was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, AVLS was rated "failed" due to the following ground: *failure to submit the required organizational structure of the Project Implementation Team for this project*;

WHEREAS, the Committee informed AVLS that they may submit a motion for reconsideration within three (3) calendar days;

WHEREAS, the Committee then opened the second envelope of Dataworld;

WHEREAS, Dataworld made a bid of P20,998,000.00.

WHEREAS, the Committee considered the bid of Dataworld for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 15, 2021, 10:00 A.M. on the bid of Dataworld. The Committee found no arithmetical correction in the financial bid of Dataworld. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated December 15, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Dataworld to be complying and declared Dataworld as the SCB at the amount of P20,998,000.00;

WHEREAS, the Committee conducted post-qualification of Dataworld on December 20, 2021;


WHEREAS, the Committee convened on December 27, 2021 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Mr. Benjamin G. Chan, Jr. of Dataworld was genuine, authentic, and responsive;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Dataworld Computer Center* as Single Calculated and Responsive Bid (SCRB) for the *Proposed Procurement for the Supply, Delivery, Installation and Commissioning of ICT Equipment for All-In-One Production Studio for the Project "Learning Management Enhancement and Establishment of 21st Century Webinar/Smart Classroom"*; and
- b) recommend the award of the contract in the total amount of **TWENTY MILLION NINE HUNDRED NINETY EIGHT THOUSAND PESOS AND 00/100 (P20,998,000.00) ONLY**.
