**BAC RESOLUTION NO. 1022-2022****BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO NEW CENTURY BOOKS AND GEN. MDSE. OF THE RE-BIDDING OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-VILLANUEVA CAMPUS 3<sup>RD</sup> QUARTER CY 2022 IN THE AMOUNT OF P2,455,804.62**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding of the Proposed Procurement for the Supply and Delivery of Library Books for USTP-Villanueva Campus 3<sup>rd</sup> Quarter CY 2022* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FIVE HUNDRED THOUSAND PESOS AND 00/100 (P2,500,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: New Century Books & Gen. MDSE. (New Century);

**WHEREAS**, during the deadline and submission of bids last October 13, 2022, 02:00 P.M., the same prospective bidder submitted its bid proposal;

**WHEREAS**, the Committee then immediately opened the first envelope of the lone bidder;

**WHEREAS**, New Century was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of New Century;

**WHEREAS**, New Century made a bid of P2,455,804.62;

**WHEREAS**, the Committee considered the bid of New Century for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last October 18, 2022, 02:00 P.M. on the bid of New Century. The Committee found no minor arithmetical correction in the financial bid of New Century. The amount of bid as read was the same as calculated;

**WHEREAS**, the Technical Representative submitted a Technical Report dated October 18, 2022;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of New Century to be complying and declared New Century as the Single Calculated Bid (SCB) at the amount of P2,455,804.62;

**WHEREAS**, the Committee conducted an on-site post-qualification of New Century Books at their office in 36 Azalea Street, Sto. Nino de Maligaya Park, Brgy. 177, Caloocan City, Metro Manila last October 27, 2022;

**WHEREAS**, the Committee convened on November 09, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Mr. Adrian Lawrence N. Gulay, Jr. of New Century was genuine, authentic and responsive;

**WHEREAS**, the Post-Qualification activities had to be extended beyond the 12-day period on account of the delay of the confirmation of the SLCC and On-Going Contracts of the New Century. The Committee had to wait for the official responses of the New Century 's previous and on-going clients:

**NOW, THEREFORE**, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) recommend for approval the extended period of post- qualification activities, that is, on October 31, 2022 – November 09, 2022 as per Section 34.8 of the Revised IRR of R.A. No. 9184;
- b) declare the bid of *New Century Books and Gen. MDSE.* as Single Calculated and Responsive Bid (SCRB) for the *Re-bidding of the Proposed Procurement for the Supply and Delivery of Library Books for USTP-Villanueva Campus 3<sup>rd</sup> Quarter CY 2022;* and
- c) recommend the award of the contract in the total amount of **TWO MILLION FOUR HUNDRED FIFTY-FIVE THOUSAND EIGHT HUNDRED FOUR PESOS AND 62/100 (P2,455,804.62) ONLY.**
