

BAC RESOLUTION NO. 0715-2023

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO GLENWOOD TECHNOLOGIES INTERNATIONAL, INC. OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING FOR MILK QUALITY AND SHELF LIFE THROUGH ULTRA-PASTEURIZATION AND SANITARY MONITORING SYSTEM FOR DAIRY AT USTP-CLAVERIA IN THE AMOUNT OF P307,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning for Milk Quality and Shelf life through Ultra-Pasteurization and Sanitary Monitoring System for Dairy at USTP-Claveria* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FIVE MILLION THREE HUNDRED TEN THOUSAND PESOS AND 00/100 (P5,310,000.00) ONLY: LOT 1 – ATP Rapid Hygiene Monitoring System (P310,000.00) LOT 2 – Ultra Pasteurization (P5,000,000.00);

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Glenwood Technologies International, Inc. (Glenwood) and Megantech Engineering Center (Megantech);

WHEREAS, on the deadline of submission of bids last October 16, 2023, 02:30 P.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, Megantech was rated "failed" due to the following ground: *The submitted Single Largest Completed Contract (SLCC) is not equal to at least fifty percent (50%) of the ABC;*

WHEREAS, Glenwood was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee informed the representative of Megantech who was present during the bid opening that they may submit a request for reconsideration *within three (3) calendar days;*

WHEREAS, the Committee then opened the second envelope of Glenwood;

WHEREAS, Glenwood made a bid of P307,000.00 for Lot 1;

WHEREAS, the Committee considered the bid of Glenwood for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated October 17, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last October 17, 2023, 03:00 P.M. on the bid of Glenwood. The Committee made no arithmetical correction in the financial bid of Glenwood, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Glenwood to be complying and declared the bid of Glenwood as the Single Calculated Bid (SCB) at the amount of P307,000.00 for Lot 1;

WHEREAS, the Committee conducted an online post-qualification of Glenwood at their main office in U3101, 31st Floor, Atlanta Centre, No. 31 Annapolis St., Greenhills, San Juan City, Metro Manila on October 24, 2023;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Kyra Monique R. Ugmad of Glenwood were genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Glenwood Technologies International, Inc.* as the Single Calculated and Responsive Bid (SCRB) of the *Re-bidding for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning for Milk Quality and Shelf life through Ultra-Pasteurization and Sanitary Monitoring System for Dairy at USTP-Claveria*; and
- b) recommend the award of the contract to the said bidder in the total amount of **THREE HUNDRED SEVEN THOUSAND PESOS AND 00/100 (P307,000.00) ONLY**;

RESOLVED this 24th day of October, 2023 at University of Science and Technology of Southern Philippines, Cagayan de Oro City.


