BAC RESOLUTION NO. 1189-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PLDT, INC. OF THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ADDITIONAL INTERNET CONNECTIVITY FOR USTP-CDO CAMPUS WIFI SERVICES IN THE AMOUNT OF P2,929,920.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Additional Internet Connectivity for USTP-CDO Campus WIFI Services* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION NINE HUNDRED THIRTY THOUSAND SEVEN HUNDRED NINETY-NINE PESOS AND 00/100 (P2,930,799.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: PLDT, Inc. (PLDT);

WHEREAS, during the deadline and submission of bids last December 14, 2022, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, PLDT was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of PLDT;

WHEREAS, PLDT made a bid of P2,929,920.00;

WHEREAS, the Committee considered the bid of PLDT for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 15, 2022, 02:30 P.M. on the bid of PLDT. The Committee found no arithmetical correction in the financial bid of PLDT. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated December 15, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of PLDT to be complying and declared PLDT as the Single Calculated Bid (SCB) at the amount of P2,929,920.00;

WHEREAS, the Committee conducted post-qualification of PLDT on December 22, 2022;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Anthony Khass R. Navales of PLDT were genuine, authentic and responsive;
