



BAC RESOLUTION NO. 189-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO ALLTEK ENGINEERING AND INDUSTRIAL SUPPLIES OF THE RE-BIDDING OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND MONITORING OF AN AIR HANDLING UNIT SYSTEM LOCATED AT 6TH FLOOR OF NEW WARD BUILDING OF NORTHERN MINDANAO MEDICAL CENTER IN THE AMOUNT OF P2,421,200.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Re-bidding of the Proposed Procurement for the Supply, Delivery, Installation, Commissioning and Monitoring of an Air Handling Unit System located at 6th Floor of New Ward Building of Northern Mindanao Medical Center* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FOUR HUNDRED THIRTY ONE THOUSAND TWO HUNDRED PESOS AND 00/100 (P2,431,200.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Alltek Engineering and Industrial Supplies (Alltek);

WHEREAS, during the deadline and submission of bids last March 28, 2022, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, Alltek was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Alltek;

WHEREAS, Alltek made a bid of P2,421,200.00;

WHEREAS, the Committee considered the bid of Alltek for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last March 29, 2022, 10:00 A.M. on the bid of Alltek. The Committee found no arithmetical correction in the financial bid of Alltek. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated March 29, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Alltek to be complying and declared Alltek as the Single Calculated Bid (SCB) at the amount of P2,421,200.00;

WHEREAS, the Committee conducted post-qualification of Alltek on March 31, 2022;

WHEREAS, the Committee convened on April 06, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Mr. Alvin T. Enriquez of Alltek was genuine, authentic, and responsive;


NOW, THEREFORE, the Bids and Awards Committee, hereby **RESOLVES**, as it is hereby **RESOLVED**,
