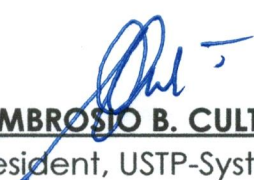

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD OF CONTRACT TO TRI FB CONSTRUCTION AND GENERAL MERCHANDISE OF THE RE-BIDDING FOR THE PROPOSED CONSTRUCTION OF COVERED COURT FOR USTP-JASAAN CAMPUS (PHASE 2) CY 2025 IN THE AMOUNT OF P1,171,399.14

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding for the Proposed Construction of Covered Court for USTP-Jasaan Campus (Phase 2) CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION THREE HUNDRED THOUSAND PESOS AND 00/100 (P1,300,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Tri FB Construction and General Merchandise (Tri FB);

WHEREAS, on the deadline for submission of bids last September 03, 2025, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Tri FB was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Tri FB;

WHEREAS, Tri FB made a bid of P1,176,232.40;

WHEREAS, the Committee considered the bid of Tri FB for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated September 08, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last September 08, 2025, 10:00 A.M. on the bid of Tri FB. The Committee made an arithmetical correction in the financial bid of Tri FB, the amount of bid as read was not the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Tri FB to be complying and declared the bid of Tri FB as the Single Calculated Bid (SCB) at the amount of P1,171,399.14;

WHEREAS, the Committee conducted an onsite post-qualification of Tri FB at their main office in Block 10, Lot 37, Phase 2, NHA, Kauswagan, Cagayan De Oro City, Misamis Oriental last September 16, 2025;

WHEREAS, the Committee requested Tri FB to submit a corrected Bid Form (Bill of Quantities) and Detailed Estimates, in accordance with DPWH D.O. No. 197, series of 2016, and Section 34.4 of the
