BAC RESOLUTION NO. 0339-2023

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO COLUMBIA COMPUTER CENTER, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF NETWORK ATTACHED STORAGE FOR USTP-CDO CY 2023 IN THE AMOUNT OF P1,540,800.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Network Attached Storage for USTP-CDO CY 2023 in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION SEVEN HUNDRED THOUSAND PESOS AND 00/100 (P1,700,000,00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Columbia Computer Center, Inc. (Columbia) and Infinitecare Technology Solutions (ITSI), Inc. (ITSI);

WHEREAS, on the deadline for submission of bids last June 19, 2023, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission:

WHEREAS, Columbia and ITSI were rated "passed" in the preliminary examination of their legal, technical and financial documents:

WHEREAS, the Committee then opened the second envelopes of Columbia and ITSI;

WHEREAS, Columbia made a bid of P1,540,800.00;

WHEREAS, ITSI made a bid of P1,648,000.00;

WHEREAS, the Committee considered the bids of Columbia and ITSI for evaluation;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 20, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee last June 20, 2023, 10:00 A.M. on the bids of Columbia and ITSI. The Committee made no arithmetical correction in the financial bids of Columbia and ITSI. The amounts of bid as read were the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Columbia and ITSI to be complying, and declared the bid of Columbia as the Lowest Calculated Bid (LCB) at the amount of P1,540,800.00;

WHEREAS, the Committee conducted an on-site post-qualification of Columbia at their main office in Tirso Neri Street, Divisoria Park, Cagayan de Oro City last June 23, 2023;

WHEREAS, the Committee verified thru email Columbia's Single Largest Completed Contract, namely: Supply and Delivery of Various Information and Communication Equipment-Rebid under PR No. 039-2021 of Department of Environment and Natural Resources - Environmental Management Bureau (DENR-EMB) Region X located in DENR Compound, Macabalan, Cagayan de Oro City with the

- a) declare the bid of Columbia Computer Center, Inc. as the Lowest Calculated and Responsive Bid (LCRB) for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Network Attached Storage for USTP-CDO CY 2023; and
- b) recommend the award of the contract in the total amount of ONE MILLION FIVE HUNDRED FORTY THOUSAND EIGHT HUNDRED PESOS AND 00/100 (P1.540.800.00) ONLY.
