BAC RESOLUTION NO. 0016-2024

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO PENTAGON UNLIMITED TECHNOLOGIES, INC. IN THE AMOUNT OF P750,000.00 (LOT 1 -650,000.00 & LOT 3 - P100,000.00), DECLARING PARTIAL FAILURE OF BIDDING AND RECOMMENDING NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT (NP-SVP) FOR LOT 2 OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY AND INSTALLATION OF ICT EQUIPMENT FOR USTP-PANAON CAMPUS (1st QUARTER CY 2024)

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the Re-bidding for the Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment for USTP-Panaon Campus (1st Quarter CY 2024) in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) OF ONE MILLION THREE HUNDRED SEVENTY-FIVE THOUSAND PESOS AND 00/100 (P1.375.000.00) ONLY: LOT 1 - ROUTING AND SWITCHING EQUIPMENT (P650,000,00), LOT 2 - ICT EQUIPMENT (P625,000,00) & LOT 3 - RACKMOUNT SERVER (P100,000.00);

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Pentagon Unlimited Technologies, Inc. (Pentagon) and BXU Copy Trading & Ent. Corp. - Dipolog Branch (BXU);

WHEREAS, on the deadline for the submission of bids last January 10, 2024, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, Pentagon was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, BXU was rated "failed" due to the following ground: Suspended validity of the Certificate of PhilGEPS Registration (Platinum Membership) submitted by the bidder for its failure to update the Certificate with the current and updated Mayor's/Business permit;

WHEREAS, the Committee informed the representative of BXU who was present during the bid opening that they may submit a request for reconsideration within three (3) calendar days;

WHEREAS, the Committee then immediately opened the second envelope of Pentagon;

WHEREAS, Pentagon made a bid of P750,000.00 (Lot 1 – P650,000.00 & for Lot 3 – P100,000.00);

WHEREAS, the Committee considered the bid of Pentagon for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated January 12, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last January 12, 2024, 10:00 A.M. on the bid of Pentagon. The Committee made no arithmetical correction in the financial bid of Pentagon, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Pentagon to be complying and declared the bid of Pentagon as the Single Calculated Bid (SCB) in the total amount of P750,000.00 (Lot 1 – P650,000.00 & Lot 3 – P100,000.00);

WHEREAS, BXU did not submit any request for reconsideration;

WHEREAS, the Committee conducted an on-site post-qualification of Pentagon at their main office in Tiano Kalambaguhan St., Cagayan de Oro City, Misamis Oriental last January 19, 2024;

WHEREAS, the Committee convened on January 23, 2024 and deliberated the results of their Post-Qualification. It was found that all the documents submitted by Mr. Raymond C. Fernando of Pentagon were genuine, authentic and responsive;

WHEREAS, Lot 1 with a total budget of P625,000.00 were not awarded to bidder;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of Pentagon Unlimited Technologies, Inc. as the Single Calculated and Responsive Bid (SCRB) for Lot 1 and 3 of the Re-bidding for the Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment for USTP-Panaon Campus (1st Quarter CY 2024);
- b) recommend the award of the contract to the said bidder in the total amount of **SEVEN HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P750,000.00) ONLY: LOT 1 P650,000.00** and LOT 3 P100,000.00;
- c) declare Partial Failure of bidding for Lot 2; and
- d) recommend Negotiated Procurement-Small Value Procurement (NP-SVP) for Lot 2 with a total budget of SIX HUNDRED TWENTY-FIVE THOUSAND PESOS AND 00/100 (P625,000.00) ONLY.
