BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO TERABIT COMPUTER SYSTEMS CORPORATION IN THE AMOUNT OF P1,490,960.00 FOR LOT 1, DECLARING PARTIAL FAILURE OF BIDDING AND RECOMMENDING NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT (NP-SVP) FOR LOT 2 OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY AND INSTALLATION OF ICT EQUIPMENT FOR USTP-ALUBIJID CAMPUS (1ST QUARTER CY 2024)

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the Re-bidding for the Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment for USTP-Alubijid Campus (1st Quarter CY 2024) in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION ONE HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P2,150,000.00) ONLY: LOT 1 – ICT EQUIPMENT (P1,500,000.00) & LOT 2 – ROUTING AND SWITCHING EQUIPMENT (P650,000.00);

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Terabit Computer Systems Corporation (Terabit);

WHEREAS, on the deadline for the submission of bids last February 27, 2024, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Terabit was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, the Committee then opened the second envelope of Terabit;

WHEREAS, Terabit made a bid of P1,490,960.00 for Lot 1;

WHEREAS, the Committee considered the bid of Terabit for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated February 28, 2024;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last February 28, 2024, 10:00 A.M. on the bid of Terabit. The Committee made no arithmetical correction in the financial bid of Terabit, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Terabit to be complying and declared the bid of Terabit as the Single Calculated Bid (SCB) at the amount of P1,490,960.00 for Lot 1;

WHEREAS, the Committee convened on March 14, 2024 and deliberated the results of their Post-Qualification. It was found that all the documents submitted by Mr. Marjon A. Pilapil of Terabit were genuine, authentic and responsive;

WHEREAS, in this case, there is no other prospective bidder for Lot 2;

WHEREAS, the Post-Qualification activities had to be extended for three (3) days beyond the 12-day period on account of the delay for the confirmation of the SLCC of Terabit;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) recommend for approval the extended period of post-qualification activities, that is, on March 12 - 14, 2024 as per Section 34.8 of the Revised IRR of R.A. No. 9184
- b) declare the bid of Terabit Computer Systems Corporation as the Single Calculated and Responsive Bid (SCRB) for Lot 1 of the Re-bidding for the Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment for USTP-Alubijid Campus (1st Quarter CY 2024);
- c) recommend the award of the contract to the said bidder in the total amount of ONE MILLION FOUR HUNDRED NINETY THOUSAND NINE HUNDRED SIXTY PESOS AND 00/100 (P1,490,960.00) ONLY for LOT 1;
- d) declare Partial Failure of bidding for Lot 2; and
- e) recommend Negotiated Procurement-Small Value Procurement (NP-SVP) for Lot 2 with a total budget of SIX HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P650,000.00) ONLY.
