BAC RESOLUTION NO. 0196-2023

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO DATAWORLD COMPUTER CENTER IN THE AMOUNT OF P783,800.00 (ITEM NO. 1 - P497,400.00 & ITEM NO. 2 - P286,400.00), DECLARING PARTIAL FAILURE OF BIDDING FOR ITEM NO. 3 AND RECOMMENDING NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT (NP-SVP) FOR ITEM NO. 3 FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF LICENSES OF OPERATING SYSTEM AND OFFICE PRODUCTIVITY TOOLS FOR USTP-CDO CY 2023

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply and Delivery of Licenses of Operating System and Office Productivity Tools for USTP-CDO CY 2023* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION ONE HUNDRED THOUSAND PESOS AND 00/100 (P1,100,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Radenta Technologies, Inc. (Radenta) and Dataworld Computer Center (Dataworld);

WHEREAS, during the deadline for submission of bids last May 24, 2023, 01:30 P.M., only Dataworld submitted its bid proposal. Radenta did not submit any bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, Dataworld was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Dataworld;

WHEREAS, Dataworld made a total bid of P783,800.00 (Item No. 1 - P497,400.00 & Item No. 2 - P286,400.00). Dataworld did not make a bid for Item No. 3 which has an approved budget of P120,000.00;

WHEREAS, the Committee considered the bid of Dataworld for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last May 25, 2023, 11:00 A.M. on the bid Dataworld. The Committee made no arithmetical correction in the financial bid of Dataworld, the amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated May 25, 2023;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Dataworld to be complying and declared the bid of Dataworld as the Single Calculated Bid (SCB) at the amount of P783,800.00 (Item No. 1 - P497,400.00 & Item No. 2 - P286,400.00);

WHEREAS, the Committee conducted an on-site post-qualification of Dataworld at their main office in 49 Don Tirso Neri Street, Cagayan de Oro City, last June 02, 2023;

WHEREAS, the Committee verified thru email Dataworld's four (4) Ongoing Contracts, namely:

1. *Rehabilitation and Upgrade of Network Infrastructure in DepEd, Misamis Oriental Division Office – Phase II (REBID) located at Del Pilar corner Velez Street, Brgy. 29, Cagayan de Oro City with the value of outstanding contract amount of P998,000.00;*
2. *Purchase of 1 Unit Desktop Computer, 1 Unit Laptop and 1 Unit A3 Printer for Office of the Building Official (per Item Basis) of Municipality of Manolo Fortich located at Manolo Fortich, Bukidnon with the value of outstanding contract amount of P216,850.00; and*
3. *Supply and Delivery of IT Equipment for Use in Public Affairs and Information Office and Supply and Delivery of IT Equipment (Computer Desktop and Laptop) of Department of Public Works and Highways (DPWH) Region X located at Engineer's Hill, Bulua, Cagayan de Oro City with the value of outstanding contract amount of P880,000.00 and P2,400,000.00, respectively.*

WHEREAS, the Municipality of Manolo Fortich and the DPWH Region X office confirmed that Dataworld provided satisfactory delivery of goods. The other projects are still ongoing and have no delivery yet;

WHEREAS, the Committee also verified thru email Dataworld's Single Largest Completed Contract, namely: *Purchase of Endpoint Security System – Antivirus of Foodsphere, Inc. (Foodsphere) located at West Service Road, Paso de Blas 560, Valenzuela City with the contract amount of P2,076,396.00. The Foodsphere confirmed that the bidder provided satisfactory delivery of goods;*

WHEREAS, the Committee convened on June 06, 2023 and deliberated the results of their Post-Qualification. It was found that all the documents submitted by Mr. Von Jeremy P. Imbong of Dataworld were genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Dataworld Computer Center* for Item Nos. 1 & 2 as the Single Calculated and Responsive Bid (SCRB) for the *Proposed Procurement of the Supply and Delivery of Licenses of Operating System and Office Productivity Tools for USTP-CDO CY 2023;*
- b) recommend the award of the contract to the said bidder in the total amount of **SEVEN HUNDRED EIGHTY-THREE THOUSAND EIGHT HUNDRED PESOS AND 00/100 (P783,800.00) ONLY: (ITEM NO. 1 - P497,400.00 and ITEM NO. 2 - P286,400.00);**
- c) declare Partial Failure of bidding for Item No. 3; and
- d) recommend Negotiated Procurement – Small Value Procurement (NP-SVP) for the Item No. 3 with the budget of **ONE HUNDRED TWENTY THOUSAND PESOS AND 00/100 (P120,000.00) ONLY.**
