## **BAC RESOLUTION NO. 0603-2023**

### **BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) RECOMMENDING AWARD TO NEW CENTURY BOOKS & GEN. MDSE. IN THE AMOUNT OF P2,449,485.50 OF THE RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-VILLANUEVA CAMPUS CY 2023**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Re-bidding for the Proposed Procurement of the Supply and Delivery of Library Books for USTP-Villanueva Campus CY 2023* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FOUR HUNDRED NINETY-NINE THOUSAND FOUR HUNDRED SEVENTY-FIVE PESOS AND 00/100 (P2,499,475.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: New Century Books & Gen. Mdse. (New Century);

**WHEREAS**, on the deadline for the submission of bids last September 13, 2023, 09:30 A.M., the same prospective bidder submitted its bid proposal;

**WHEREAS**, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, New Century was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of New Century;

**WHEREAS**, New Century made a bid of P2,449,485.50;

**WHEREAS**, the Committee considered the bid of New Century for evaluation;

**WHEREAS**, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated September 14, 2023;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee last September 15, 2023, 10:00 A.M. on the bid of New Century. The Committee made no arithmetical correction in the financial bid of New Century, the amount of the bid as read was the same as calculated;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of New Century to be complying and declared the bid of New Century as the Single Calculated Bid (SCB) at the amount of P2,449,485.50;

**WHEREAS**, the Committee conducted an online post-qualification of New Century at their main office in 36 Azalea Street, Sto. Nino de Maligaya Park, Brgy. 177, Caloocan City, Metro Manila on September 21, 2023;

**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Jonnalyn N. Cabasal of New Century were genuine, authentic and responsive;





to:


