BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO XITRIX COMPUTER CORPORATION FOR LOT 1 IN THE AMOUNT OF P3,051,000.00 AND SOLIDMARK, INC. FOR LOT 2 IN THE AMOUNT OF P239,490.00 FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY AND INSTALLATION OF ICT EQUIPMENT AND AIR-CONDITIONING UNITS FOR USTP-OROQUIETA CAMPUS (1ST QUARTER CY 2024)

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment and Air-Conditioning Units for USTP-Oroquieta Campus (1st Quarter CY 2024)* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of THREE MILLION FIVE HUNDRED TWENTY THOUSAND PESOS AND 00/100 (P3,520,000.00) ONLY: LOT 1 – ICT EQUIPMENT (P3,240,000.00) & LOT 2 – AIR-CONDITIONING UNITS (P280,000.00);

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: C & G Refrigeration and Airconditioning Service Center (C & G), Xitrix Computer Corporation (Xitrix) and Solidmark, Inc. (Solidmark);

WHEREAS, on the deadline for submission of bids last November 22, 2023, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in the order of their submission;

WHEREAS, Xitrix, C & G and Solidmark were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelopes of Xitrix, C & G and Solidmark;

WHEREAS, Xitrix made a bid of P3,051,000.00 for Lot 1;

WHEREAS, C & G made a bid of P241,000.00 for Lot 2;

WHEREAS, Solidmark made a bid of P3,350,700.00 (Lot 1 – P3,111,210.00 & Lot 2 – P239,490.00);

WHEREAS, the Committee considered the bids of Xitrix, C & G and Solidmark for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated November 24, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, on November 24, 2023, 01:00 P.M. on the bids of Xitrix, C & G and Solidmark. The Committee made no arithmetical correction in the financial bids of Xitrix, C & G and Solidmark, the amount of bid as read were the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Xitrix, C & G and Solidmark to be complying and declared the bids of Xitrix and Solidmark as the Lowest Calculated Bid (LCB) for Lot 1 and Lot 2, respectively;

WHEREAS, the Committee conducted a post-qualification of the following bidders: A. Xitrix main office is located in 23 Detroit St. Cor Don Egea St., Brgy. Pinagkaisahan, Cubao, Quezon City, Metro Manila last November 29, 2023 and B. Solidmark branch office is located in Pacana-Velez Street, Cagayan de Oro City, Misamis Oriental last November 30, 2023;

WHEREAS, the Committee convened on December 06, 2023 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Ms. Lizel Rombano of Xitrix and Ms. Iris R. Arbuis of Solidmark were genuine, authentic and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bids of Xitrix Computer Corporation for Lot 1 and Solidmark, Inc. for Lot 2 as the Lowest Calculated and Responsive Bids (LCRB) for the Proposed Procurement of the Supply, Delivery and Installation of ICT Equipment and Air-Conditioning Units for USTP-Oroquieta Campus (1st Quarter CY 2024);
- b) recommend the award of the contract to Xitrix Computer Corporation for Lot 1 in the total amount of THREE MILLION FIFTY-ONE THOUSAND PESOS AND 00/100 (P3,051,000.00) ONLY; and
- c) recommend the award of the contract to Solidmark, Inc. for Lot 2 in the total amount of TWO HUNDRED THIRTY-NINE THOUSAND FOUR HUNDRED NINETY PESOS AND 00/100 (P239,490.00) ONLY.
