BAC RESOLUTION NO. 1053-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB), RECOMMENDING AWARD TO CD BOOKS INTERNATIONAL, INCORPORATED IN THE AMOUNT OF P188,543.00, DECLARING PARTIAL FAILURE OF BIDDING AND RECOMMENDING NEGOTIATED PROCUREMENT-SMALL VALUE PROCUREMENT (NP-SVP) FOR THE REMAINING ITEMS OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-OROQUIETA CAMPUS CY 2022

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement for the Supply and Delivery of Library Books for USTP-Oroquieta Campus CY 2022* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION PESOS AND 00/100 (P1,000,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: CD Books International, Incorporated (CD Books);

WHEREAS, during the deadline and submission of bids last October 24, 2022, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, CD Books was rated "passed" in the preliminary examination of its legal, technical, and financial documents;

WHEREAS, the Committee then opened the second envelope of CD Books;

WHEREAS, CD Books made a bid of P188,543.00;

WHEREAS, the Committee considered the bid of CD Books for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last October 26, 2022, 03:00 P.M. on the bid of CD Books. The Committee found no arithmetical correction in the financial bid of CD Books. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated October 26, 2022;

WHEREAS, The Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of CD Books to be complying and declared CD Books as the Single Calculated Bid (SCB) at the amount of P188,543.00;

WHEREAS, the Committee conducted on-site post-qualification of CD Books at their office in 2nd Floor, R & M Building, Zone 2, Kauswagan, Cagayan de Oro City, Misamis Oriental on November 04, 2022;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Mardan D. Dawaling of CD Books was genuine, authentic and responsive;

WHEREAS, in total, there are seventy-two (72) items, with a total budget of P785,847.00 were not awarded to bidder;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *CD Books International, Incorporated* for Item Nos. 1, 2, 3, 4, 5, 8,10, 12, 13, 19, 20, 21, 25, 28, 31, 33, 34, 36, 38, 39, 60, 69, 70, 71, 75, 76, 81, 83, 89, 92, 95 & 104 as the *Single Lowest Calculated and Responsive Bid (SCRB)* of the *Proposed Procurement for the Supply and Delivery of Library Books for USTP-Oroquieta Campus CY 2022*;
- b) recommend the award of the contract in the total amount of **ONE HUNDRED EIGHTY-EIGHT THOUSAND FIVE HUNDRED FORTY-THREE PESOS AND 00/100 (P188,543.00) ONLY**;
- c) declare Partial Failure of bidding for the remaining seventy-two (72) items; and
- d) recommend the Negotiated Procurement-Small Value Procurement (NP-SVP) for the remaining items with a total budget of **SEVEN HUNDRED EIGHTY-FIVE THOUSAND EIGHT HUNDRED FORTY-SEVEN PESOS AND 00/100 (P785,847.00) ONLY**.


