## BAC RESOLUTION NO. 1169-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO XAVEXCOM TECHNOLOGY, INC. OF THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF ELEVATOR FOR USTP-CDO FOOD INNOVATION CENTER BUILDING IN THE AMOUNT OF P1,978,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Elevator for USTP-CDO Food Innovation Center Building in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION ONE HUNDRED TWENTY-ONE THOUSAND FIVE HUNDRED ONE PESOS AND 65/100 (P2,121,501.65) ONLY;

**WHEREAS**, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: APTS Industrial Equipment, Corp. (APTS), Xavexcom Technology, Inc. (Xavexcom) and Tech A Byte Enterprises (Tech A Byte);

**WHEREAS**, during the deadline and submission of bids last November 22, 2022, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in chronological order:

**WHEREAS**, Xavexcom was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, Tech A Byte was rated "failed" due to the following ground: Non submission of certification of Service Center within the Philippines;

**WHEREAS**, APTS was rated "failed" due to the following ground: SLCC is not supported by End User's Acceptance or Official Receipt or Sales Invoice issued for the contract;

WHEREAS, the Committee then opened the second envelope of Xavexcom;

WHEREAS, Xavexcom made a bid of P1.978.000.00:

WHEREAS, the Committee considered the bid of Xavexcom for evaluation;

**WHEREAS,** The Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last November 24, 2022, 01:00 P.M. on the bid of Xavexcom. The Committee found no arithmetical correction in the financial bid of Xavexcom. The amount of bid as read was the same as calculated:

**WHEREAS**, The Technical Representative and TWG submitted a Technical Report dated November 24, 2022;

**WHEREAS**, The Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Xavexcom to be complying and declared Xavexcom as the Single Calculated Bid (SCB) at the amount of P1,978,000.00;

**WHEREAS**, Tech A Byte submitted a letter-request for reconsideration dated November 23, 2022 and received November 24, 2022 which the BAC denied in a letter sent on November 24, 2022;

**WHEREAS**, APTS submitted a letter-request for reconsideration dated and received November 24, 2022 which the BAC denied in a letter sent on November 24, 2022;

**WHEREAS**, the Committee conducted on-site post-qualification of Xavexcom at their office in Plaza Cristina Bldg., Dolores City of San Fernando, Pampanga last November 28, 2022;

**WHEREAS**, the Committee convened on December 06, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Ms. Ruby Anne G. Figueroa of Xavexcom was genuine, authentic and responsive;

**WHEREAS**, pursuant to the Revised IRR of R.A. 9184, following completion of the negotiations, the Committee requested the supplier in the proceedings to submit not later than December 09, 2022 their best offer based on the final technical and financial requirements;

**WHEREAS**, on December 09, 2022, Xavexcom submitted their best offer in a form of accomplished financial bid form (bill of quantities). Their best offer is identical to the original bid as calculated;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED,

to:

- a) declare the bid of Xavexcom Technology, Inc. as the Single Lowest Calculated and Responsive Bid (SCRB) of the Negotiated Procurement Under Two-Failed Biddings of the Proposed Procurement for the Supply, Delivery, Installation and Commissioning of Elevator for USTP-CDO Food Innovation Center Building;
- b) recommend the award of the contract in the total amount of **ONE MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND PESOS AND 00/100 (P1,978,000.00) ONLY.**
