BAC RESOLUTION NO. 543-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO DQT BUILDERS & SUPPLY FOR THE PROPOSED RENOVATION OF INTEGRATED TECHNOLOGY BUILDING FOR COLLEGE OF MEDICINE IN THE AMOUNT OF P4,113,357.78

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Renovation of Integrated Technology Building for College of Medicine in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of FOUR MILLION EIGHT HUNDRED EIGHTY-NINE THOUSAND EIGHT HUNDRED SIXTY-NINE PESOS AND 53/100 (P4,889,869.53) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: DQT Builders & Supply (DQT) and Roce Construction and Supply (Roce);

WHEREAS, during the deadline and submission of bids last June 01, 2022, 03:30 P.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee then opened the first envelope of the following prospective bidders in chronological order;

WHEREAS, DQT was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, Roce was rated "failed" due to the following ground: Suspended validity of the Certificate of PhilGEPS Registration (Platinum Membership) submitted by the bidder for its failure to update the Certificate with the current and updated Tax Clearance and Mayors Permit;

WHEREAS, the Committee informed Roce that they may submit a motion for reconsideration within three (3) calendar days;

WHEREAS, the Committee then immediately opened the second envelope of DQT;

WHEREAS, DQT made a bid of P4,113,809,28;

WHEREAS, the Committee considered the bid of DQT for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last June 02, 2022, 03:30 P.M. on the bid of DQT. The Committee found minor arithmetical correction in the financial bid of DQT. The amount of bid as read was not the same as calculated:

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 02, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of DQT to be complying and declared DQT as the Single Calculated Bid (SCB) at the amount of P4,113,357.78;

WHEREAS, the Committee conducted post-qualification of DQT on June 06, 2022;

WHEREAS, during post-qualification, it was found that DQT's computation of NFCC was incorrect. The verified computation of NFCC done by BAC is P53,754,734.48. Accordingly, the Committee allowed DQT to submit a corrected NFCC which DQT then submitted;

WHEREAS, the Committee also requested DQT to submit a corrected Bid Form (Bill of Quantities) and Detailed Estimate, both updated with respect to Item No. 1 only to reconcile with the bid as calculated which is in accordance with DPWH D.O. No. 197, series of 2016. DQT was able to submit the required documents;

WHERAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Danny Q. Tampan of DQT was genuine, authentic, and responsive;

WHERAS, no request for reconsideration was received by the BAC Secretariat from Roce;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of DQT Builders & Supply as the Single Calculated and Responsive Bid (SCRB) for the Proposed Renovation of Integrated Technology Building for College of Medicine; and
- b) recommend the award of the contract to the said bidder in the total amount of FOUR MILLION ONE HUNDRED THIRTEEN THOUSAND THREE HUNDRED FIFTY-SEVEN PESOS AND 78/100 ONLY (P4,113,357.78).
