BAC RESOLUTION NO. 561-2021

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO DAVS TRADERS AND SERVICES FOR THE PROPOSED IMPROVEMENT OF ENGINEERING LABORATORIES AT USTP-CDO CAMPUS IN THE AMOUNT OF P1,123,452.43

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Proposed Improvement of Engineering Laboratories at USTP-CDO Campus in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED FORTY NINE THOUSAND THREE HUNDRED SEVENTY TWO PESOS AND 20/100 (P1,249,372.20) ONLY;

WHEREAS, in response to the said advertisement, four (4) prospective bidders acquired the bidding documents, namely: Davs Traders and Services (Davs Traders), Edmond Ray Construction (Edmond Ray), Roce Construction and Supply (Roce Construction) and L.G. Lasacar Construction (L.G. Lasacar);

WHEREAS, during the deadline and submission of bids last August 31, 2021, 10:00 A.M., only Roce Construction, Davs Traders and L.G. Lasacar submitted their bid proposals. Edmond Ray did not submit any bid proposal;

WHEREAS, the Committee then opened the first envelope of the following prospective bidders in chronological order:

WHEREAS, Roce Construction and Davs Traders were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, L.G. Lasacar was rated "failed" due to the following ground: SLCC submitted was not supported by the project owner's Certificate of Final Acceptance issued for the contract in accordance with 2016 Revised IRR of R.A. 9184 Section 23.4.2.5;

WHEREAS, the Committee informed L.G. Lasacar that they may submit a letter-request for reconsideration within three (3) calendar days;

WHEREAS, the BAC then immediately opened the second envelope of Roce Construction and Davs Traders:

WHEREAS, Roce Construction made a bid of P1,124,958.88;

WHEREAS, Davs Traders made a bid of P1,124,435.23;

WHEREAS, the Committee considered the bids of Roce Construction and Davs Traders for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last September 01, 2021, 10:00 A.M. on the bids of Roce Construction and Davs Traders. The Committee found no minor arithmetical correction in the financial bid of Roce Construction. The amount of bid as read was the same as calculated, However, the Committee found minor arithmetical correction in the financial bid of Davs Traders. The amount of bid as read was not the same as calculated:

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated September 01.

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Roce Construction and Davs Traders to be complying;

WHEREAS, Davs Traders was declared as the Lowest Calculated Bid (LCB) with an amount of P1,123,452.43;

WHEREAS, the Committee conducted post-qualification of Davs Traders on September 06, 2021;

WHERAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ar. Dave Jeremiah M. Barcelona of Davs Traders was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of Davs Traders and Services as the Lowest Calculated and Responsive Bid (LCRB) for the Proposed Improvement of Engineering Laboratories at USTP-CDO Campus; and
- recommend the award of the contract to the said bidder in the total amount of ONE MILLION ONE HUNDRED TWENTY THREE THOUSAND FOUR HUNDRED FIFTY TWO PESOS AND 43/100 ONLY (P1,123,452.43);
