BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO INFINITECARE TECHNOLOGY SOLUTIONS (ITSI), INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF NEXT GENERATION FIREWALL FOR USTP-CDO CY 2023 IN THE AMOUNT OF P2,650,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Next Generation Firewall for USTP-CDO CY 2023* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION EIGHT HUNDRED THOUSAND PESOS AND 00/100 (P2,800,000.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Infinitecare Technology Solutions (ITSI), Inc. (ITSI);

WHEREAS, on the deadline for submission of bids last June 06, 2023, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, ITSI was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of ITSI;

WHEREAS, ITSI made a bid of P2,650,000.00;

WHEREAS, the Committee considered the bid of ITSI for evaluation;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 07, 2023;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last June 07, 2023, 02:00 P.M. on the bid of ITSI. The Committee made no arithmetical correction in the financial bid of ITSI, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of ITSI to be complying, and declared the bid of ITSI as the Single Calculated Bid (SCB) at the amount of P2,650,000.00;

WHEREAS, the Committee conducted an on-site post-qualification of ITSI at their main office in JV Serina Street, Zone 6, Carmen, Cagayan de Oro City last June 16, 2023;

WHEREAS, the Committee verified thru email ITSI's Single Largest Completed Contract, namely: Supply, Delivery, Installation, Testing and Commissioning of MOTC – Information Technology Infrastructure for MOTC of the Ministry of Transportation and Communications - BARMM located at MOTC Building, BARMM Compound, Cotabato City with the contract amount of P43,688,788.00. The MOTC - BARMM confirmed that the bidder provided satisfactory delivery of goods;

- b) declare the bid of Infinitecare Technology Solutions (ITSI), Inc. as the Single Calculated and Responsive Bid (SCRB) for the Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Next Generation Firewall for USTP-CDO CY 2023; and
- c) recommend the award of the contract to the said bidder in the total amount of **TWO MILLION SIX HUNDRED FIFTY THOUSAND PESOS AND 00/100 (P2,650,000.00) ONLY.**
