BAC RESOLUTION NO. 1025-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO TRENCH ENGINEERING AND CONSTRUCTION SERVICES FOR THE NEGOTIATED PROCUREMENT UNDER TWO-FAILED BIDDINGS OF THE PROPOSED RENOVATION OF FOUR (4) CLASSROOMS AT USTP-JASAAN CAMPUS IN THE AMOUNT OF P1,115,593.71

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the Negotiated Procurement Under Two-Failed Biddings of the Proposed Renovation of Four (4) Classrooms at USTP-Jasaan Campus in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED TWO THOUSAND SIXTY-FOUR PESOS AND 28/100 (P1,202,064.28) ONLY;

WHEREAS, in response to the said advertisement, five (5) prospective bidders acquired the bidding documents, namely: DQT Builders & Supply (DQT Builders), Trench Engineering and Construction Services (Trench Engineering), Caliber Industrial Sales Corp. (Caliber Industrial), Level & Square Engineering, Inc. (Level & Square) and Oikea Builders;

WHEREAS, during the deadline and submission of bids last October 20, 2022, 09:30 A.M., only Trench Engineering and DQT Builders submitted their bid proposals. Level & Square, Caliber Industrial and Oikea Builders did not submit any bid proposal;

WHEREAS, the Committee then opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, Trench Engineering was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, DQT Builders was rated "failed" due to the following ground: SLCC is not supported by Notice of Award and/or Notice to Proceed, Project Owner's Certificate of Final Acceptance issued by the Owner other than the Contractor or the Constructors Performance Evaluation System (CPES) Final Rating;

WHEREAS, the Committee informed DQT Builders that they may submit a motion for reconsideration within three (3) calendar days;

WHEREAS, the Committee then immediately opened the second envelope of Trench Engineering;

WHEREAS, Trench Engineering made a bid of P1,117,196.01;

WHEREAS, the Committee considered the bid of Trench Engineering for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last October 24, 2022, 03:00 P.M. on the bid of Trench Engineering. The Committee found minor arithmetical correction in the financial bid of Trench Engineering. The amount of bid as read was not the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated October 24, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Trench Engineering to be complying and declared Trench Engineering as the Single Calculated Bid (SCB) at the amount of P1,115,593.71;

WHERAS, DQT Builders did not submit any request for reconsideration;

WHEREAS, the Committee conducted an on-site post-qualification of Trench Engineering at their branch office in Zone 2, Santa Cruz, Tibasak, Macasandig, Cagayan de Oro City, Misamis Oriental on October 26, 2022;

WHEREAS, the Committee requested Trench Engineering to submit corrected Bid Form (Bill of Quantities) and Detailed Estimate, both updated with respect to Item No. 1 to reconcile with the bid as calculated which is in accordance with DPWH D.O. No. 197, Series of 2016. Trench Engineering was able to submit the required documents;

WHERAS, the Committee convened on October 28, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Engr. Roald Y. Dy of Trench Engineering Construction was genuine, authentic and responsive;

WHEREAS, pursuant to the Revised IRR of R.A. 9184, following completion of the negotiations, the Committee requested the supplier in the proceedings to submit not later than October 31, 2022 their best offer based on the final technical and financial requirements;

WHEREAS, on October 31, 2022, Trench Engineering submitted their best offer in a form of accomplished financial bid form (bill of quantities). Their best offer is identical to the original bid as calculated;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) déclare the bid of Trench Engineering and Construction Services as the Single Calculated and Responsive Bid (SCRB) for the Negotiated Procurement Under Two-Failed Biddings of the Proposed Renovation of Four (4) Classrooms at USTP-Jasaan Campus; and
- b) recommend the award of the contract to the said bidder in the total amount of ONE MILLION ONE HUNDRED FIFTEEN THOUSAND FIVE HUNDRED NINETY-THREE PESOS AND 71/100 ONLY (P1,115,593.71).
