BAC RESOLUTION NO. 1199-2022

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO DOUBLE DRAGON SECURITY FORCES AGENCY, INC. OF THE PROPOSED PROCUREMENT OF SECURITY SERVICES FOR USTP-PANAON CAMPUS CY 2023 IN THE AMOUNT OF P892,664.34

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of Security Services for USTP-Panaon Campus CY 2023* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of NINE HUNDRED FORTY-EIGHT THOUSAND FIFTY PESOS AND 01/100 (P948,050.01) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Double Dragon Security Forces Agency, Inc. (Double Dragon);

WHEREAS, during the deadline and submission of bids last December 20, 2022, 03:00 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then immediately opened the first envelope of the lone bidder;

WHEREAS, Double Dragon was rated "passed" in the preliminary examination of its legal, technical, and financial documents;

WHEREAS, the Committee then opened the second envelope of Double Dragon;

WHEREAS, Double Dragon made a bid of P943,351.12;

WHEREAS, the Committee considered the bid of Double Dragon for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 21, 2022, 02:00 P.M. on the bid of Double Dragon. The Committee found no arithmetical correction in the financial bid of Double Dragon. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated December 21, 2022;

WHEREAS, The Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Double Dragon to be complying and declared Double Dragon as the Single Calculated Bid (SCB) at the amount of P892,664.34;

WHEREAS, the Committee conducted post-qualification of Double Dragon on December 23, 2022;


