#### **BAC RESOLUTION NO. 1202-2022**

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING TO THE BOARD OF REGENTS THE AWARD OF CONTRACT TO CDH BUILDERS, INC. FOR THE PROPOSED COMPLETION OF CONSTRUCTION OF THREE (3) STOREY UNIVERSITY HEALTH CENTER (PHASE 2) IN THE AMOUNT OF P24,225,756.76

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Completion of Construction of Three (3) Storey University Health Center (Phase 2)* in PhilGEPS, University Website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWENTY-FIVE MILLION PESOS AND 00/100 (P25,000,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: CDH Builders, Inc. (CDH Builders);

**WHEREAS**, during the deadline and submission of bids last December 27, 2022, 01:30 P.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee then opened the first envelope of the lone bidder;

**WHEREAS**, CDH Builders was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then immediately opened the second envelope of CDH Builders;

WHEREAS, CDH Builders made a bid of P24,231,237.74;

WHEREAS, the Committee considered the bid of CDH Builders for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last December 28, 2022, 04:00 P.M. on the bid of CDH Builders. The Committee found minor arithmetical correction in the financial bid of CDH Builders. The amount of bid as read was not the same as calculated;

**WHEREAS**, the Technical Representative and TWG submitted a Technical Report dated December 28, 2022:

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of CDH Builders to be complying and declared CDH Builders as the Single Calculated Bid (SCB) at the amount of P24,225,756.76;

**WHEREAS**, the Committee conducted an on-site post-qualification of CDH Builders at their branch office in #88 30-32 St., Nazareth, Cagayan de Oro City on December 30, 2022;

**WHERAS**, the Committee requested CDH Builders to submit corrected Bid Form (Bill of Quantities) and Detailed Estimate, both updated with respect to Item No. A.1.2, which is in accordance with DPWH D.O. No. 197, Series of 2016. CDH Builders was able to submit the required documents;

**NOW, THEREFORE,** the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of CDH Builders, Inc. as the Single Calculated and Responsive Bid (SCRB) for the Proposed Completion of Construction of Three (3) Storey University Health Center (Phase 2); and
- b) recommend the award of the contract to the said bidder in the total amount of **TWENTY-FOUR MILLION TWO HUNDRED TWENTY-FIVE THOUSAND SEVEN HUNDRED FIFTY-SIX PESOS AND 76/100 (P24,225,756.76) ONLY.**
