

Proposed Interior Renovation for Career Center

CONTRACT AGREEMENT

THIS AGREEMENT, made this 29th day of December, 2021 between *University of Science and Technology of Southern Philippines (USTP) – CDO Campus, with office address at C.M. Recto Ave., Lapasan, Cagayan de Oro City* (hereinafter called the “Entity”) and *Roce Construction and Supply, Zone 6, Mahayahay Bugo, Cagayan de Oro City, Misamis Oriental* (hereinafter called the “Contractor”).

WHEREAS, the Entity is desirous that the Contractor execute *Proposed Interior Renovation for Career Center (Contract No. USTP-IFPB-11-2021-1284-011)* (hereinafter called “the Works”) and the Entity has accepted the Bid for *ONE MILLION THREE THOUSAND NINETY-SIX PESOS AND 25/100 ONLY (P1,003,096.25)* with a C.A. No. 21-12-0008 by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.:*
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - c. Performance Security;

- d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of *ONE MILLION THREE THOUSAND NINETY SIX PESOS AND 25/100 ONLY (P1,003,096.25)* or such other sums as may be ascertained, *Roce Construction and Supply* agrees to *Interior Renovation for Career Center* in accordance with his/her/its Bid.
 4. The *USTP-CDO* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.


