CONTRACT AGREEMENT

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz*.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract documents or information prescribed by the GPPB</u>

In consideration for the sum of FOUR MILLION FOUR HUNDRED FORTY EIGHT THOUSAND SIX HUNDRED THIRTY NINE PESOS AND 61/100 (P4,448,639.61) ONLY or such other sums as may be ascertained, BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc. agrees to the Contract for one (1) year and subject for evaluation and recommendation of the Head of Campus Safety Security Unit and shall take effect after midnight of May 31, 2021 in accordance with his/her/its Bid.
- 4. The *USTP-CDO Campus* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
