



**BAC RESOLUTION NO. 280-2021**

**BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO SUPER PAGES TRADING OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF LIBRARY BOOKS FOR USTP-CDO (1<sup>ST</sup> QUARTER 2021) IN THE AMOUNT OF P2,056,062.80**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Proposed Procurement for the Supply and Delivery of Library Books for USTP-CDO (1<sup>st</sup> Quarter 2021), in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION NINETY-NINE THOUSAND NINE HUNDRED EIGHTY-FIVE PESOS AND 00/100 (P2,099,985.00) ONLY;

**WHEREAS**, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Super Pages Trading (Super Pages);

**WHEREAS**, during the deadline and submission of bids last June 01, 2021, 10:00 A.M., the same prospective bidder submitted their bid proposal;

**WHEREAS**, the Committee opened the first envelope of the lone bidder;

**WHEREAS**, Super Pages was rated "passed" in the preliminary examination of its legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of Super Pages;

**WHEREAS**, Super Pages made a bid of P2,056,062.80;

**WHEREAS**, the Committee considered the bid of Super Pages for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last June 02, 2021, 10:00 A.M. on the bid of Super Pages. The Committee made no arithmetical correction in the financial bids of Super Pages. The amount of bid as read was the same as calculated;

**WHEREAS**, in the Bid Form there is discrepancies in item no. 220. As per 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 Section 32.2.3 "In case of discrepancies between xxx (b) "Total price per item and unit price for the item as extended or multiplied by the quantity of that item, the latter shall prevail; and (c), stated total price and the actual sum of prices of component items, the latter shall prevail;". Therefore, the unit price for Item no. 220 is considered.

**WHEREAS**, the Technical Representative and TWG submitted a Technical Report dated June 02, 2021;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Super Pages to be complying and declared Super Pages as the Single Calculated Bid (SCB) at the amount of P2,056,062.80;

**WHEREAS**, the Committee conducted post-qualification of Super Pages on June 08, 2021;



**WHEREAS** the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Ms. Catherine C. Alcama of Super Pages were genuine, authentic, and responsive;

**NOW, THEREFORE** the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:


- a) declare the bid of *Super Pages Trading* as Single Calculated and Responsive Bid (SCRB) for the *Proposed Procurement for the Supply and Delivery of Library Books for USTP-CDO (1<sup>st</sup> Quarter 2021)*; and
- b) recommend the award of the contract in the total amount of **TWO MILLION FIFTY SIX THOUSAND SIXTY TWO PESOS AND 80/100 (P2,056,062.80) ONLY.**


