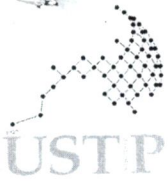

BAC RESOLUTION NO. 615-2022

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BIDS (LCRB) AND RECOMMENDING AWARD TO GLOBE TELECOM, INC. FOR ITEM NO. 1 AND SMART COMMUNICATIONS, INC. FOR ITEM NO. 2 OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF E-LOAD FOR USTP-CDO (2ND QUARTER FY 2022)

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply and Delivery of E-Load for USTP-CDO (2nd Quarter FY 2022)* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FOUR HUNDRED THOUSAND PESOS AND 00/100 (P2,400,000.00) ONLY;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Globe Telecom, Inc. (Globe) and Smart Communications, Inc. (Smart);

WHEREAS, during the deadline and submission of bids last June 13, 2022, 10:00 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee then immediately opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, Globe and Smart were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelopes of Globe and Smart;

WHEREAS, Globe made a bid of P1,800,000.00 for Item No. 1;

WHEREAS, Smart made a bid of P600,000.00 for Item No. 2;

WHEREAS, the Committee considered the bids of Globe and Smart for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last June 14, 2022, 10:00 A.M. on the bids of Globe and Smart. The Committee found no minor arithmetical correction in the financial bids of Globe and Smart. The amounts of bids as read were the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 14, 2022;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Globe and Smart to be complying;

WHEREAS, Globe and Smart are declared as the LCB at the amount of P1,800,000.00 for Item No. 1 and P600,000.00 for Item No. 2, respectively;

WHEREAS, the Committee conducted post-qualification of Globe and Smart on June 16, 2022;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Jerome John S. Selim of Globe and Mr. Anthony Khass R. Navales of Smart were genuine, authentic and responsive;
