



**BAC RESOLUTION NO. 561-2022**

**BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO HAWK RESCUE EQUIPMENT AND GENERAL MERCHANDISE OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY OF ICT EQUIPMENT FOR USTP-OROQUIETA CAMPUS IN THE AMOUNT OF P998,000.00**

**WHEREAS**, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for *Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-Oroquieta Campus* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION PESOS AND 00/100 (P1,000,000.00) ONLY;

**WHEREAS**, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents, namely: Hawk Rescue Equipment and General Merchandise (Hawk Rescue) and Masangkay Computer Center (Masangkay);

**WHEREAS**, during the deadline and submission of bids last June 06, 2022, 02:00 P.M., the same prospective bidder submitted their bid proposals;

**WHEREAS**, the Committee then immediately opened the first envelope of the following prospective bidders in chronological order;

**WHEREAS**, Masangkay and Hawk Rescue were rated "passed" in the preliminary examination of their legal, technical and financial documents;

**WHEREAS**, the Committee then opened the second envelope of Masangkay and Hawk Rescue;

**WHEREAS**, Masangkay made a bid of P999,800.00;

**WHEREAS**, Hawk Rescue made a bid of P998,000.00;

**WHEREAS**, the Committee considered the bids of Masangkay and Hawk Rescue for evaluation;

**WHEREAS**, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on June 07, 2022, 02:00 P.M. on the bids of Masangkay and Hawk Rescue. The Committee found no arithmetical correction in the financial bids of Masangkay and Hawk Rescue. The amount of bids as read were the same as calculated;

**WHEREAS**, the Technical Representative and TWG submitted a Technical Report dated June 07, 2022;

**WHEREAS**, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Masangkay and Hawk Rescue to be complying;

**WHEREAS**, Hawk Rescue was declared as the LCB at the amount of P998,000.00;

**WHEREAS**, the Committee conducted post-qualification of Hawk Rescue on June 09, 2022;


**WHEREAS**, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Jacinto R. Trio, Jr. of Hawk Rescue were genuine, authentic, and responsive;

- a) declare the bid of *Hawk Rescue Equipment and General Merchandise* as the Lowest Calculated and Responsive Bid (LCRB) of the *Proposed Procurement for the Supply and Delivery of ICT Equipment for USTP-Oroquieta Campus*;
- b) recommend the award of the contract in the total amount of **NINE HUNDRED NINETY-EIGHT THOUSAND PESOS AND 00/100 (P998,000.00) ONLY**.
