BAC RESOLUTION NO. 742-2022

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BIDS (LCRB) AND RECOMMENDING AWARD TO PARASAT CABLE TV, INC. FOR ITEM NO. 1 AND PLDT, INC. FOR ITEM NO. 3 OF THE PROPOSED PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF WAN DARK FIBER RENTAL AND INTERNET CONNECTIVITY FOR USTP

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement for the Supply, Delivery, Installation and Commissioning of WAN Dark Fiber Rental and Internet Connectivity for USTP* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of SEVEN MILLION FOUR HUNDRED FIFTY THOUSAND EIGHT HUNDRED PESOS AND 00/100 (P7,450,800.00) ONLY;

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: Parasat Cable TV, Inc. (Parasat), PLDT, Inc. (PLDT) and DCTech Micro Services, Inc. (DCTech);

WHEREAS, during the deadline and submission of bids last July 27, 2022, 02:00 P.M., the same prospective bidders submitted their bid proposal;

WHEREAS, the Committee opened the first envelopes of the prospective bidders in chronological order;

WHEREAS, Parasat and PLDT were rated "passed" in the preliminary examination of their legal, technical and financial documents;

WHEREAS, DCTech was rated "failed" due to the following grounds: *Non-compliant to the Technical Specifications, specifically for Item no. 3. and Non submission of Additional Requirements to support the bidder's conformity with Technical Specifications.*

WHEREAS, the Committee informed DCTech that they may submit a motion for reconsideration within three (3) calendar days;

WHEREAS, the Committee then opened the second envelopes of Parasat and PLDT;

WHEREAS, Parasat made a bid of P7,450,800.00 (per Financial Bid Form (Appendix 1)) / P4,308,000.00 (per Revised Bid Form duly signed by BAC Chairperson);

WHEREAS, PLDT made a bid of P423,360.00;

WHEREAS, the Committee considered the bids of Parasat and PLDT for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), last July 29, 2022, 11:00 A.M. and was continued on August 02, 2022 on the bids of Parasat and PLDT. The Committee found no minor arithmetical correction in the financial bid of PLDT. The amount of bid as read was the same as calculated. However, the Committee has determined that the total bid amount indicated in Parasat's submitted Financial Bid Form (Appendix 1) does not reconcile with the total bid price indicated in their accomplished Revised Bid Form duly signed by BAC Chairperson;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated July 29, 2022;

WHEREAS, Accordingly, the Committee requested Parasat for clarification of its bid in a letter dated July 29, 2022. In response to the request, Parasat clarified, in a letter dated July 30, 2022, that the total bid amount indicated in their submitted Financial Bid Form (Appendix 1) is a typographical error and that the amount indicated in Revised Bid Form is the correct price;

WHEREAS, DCTech submitted a letter-request for reconsideration dated July 28, 2022 and received July 29, 2022 which the BAC denied on August 01, 2022;

WHEREAS, Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Parasat and PLDT to be complying;

WHEREAS, Parasat and PLDT are declared as the LCB at the amount of P4,308,000.00 for Item No. 1 and P423,360.00 for Item No. 3, respectively;

WHEREAS, the Committee conducted an on-site post-qualification of Parasat at their office in Corrales Avenue cor. Ramons Chavez Sts., Cagayan de Oro City on August 12, 2022 and an online post-qualification of PLDT on August 16, 2022;

WHEREAS, during post-qualification, it was found that Parasat's computation of NFCC was incorrect. The Bidder's NFCC computation was not based on its submitted List of Ongoing Government and Private Contracts. The verified computation of NFCC done by BAC is P60,386,735.85. Accordingly, the Committee allowed Parasat to submit a corrected NFCC which Parasat then submitted;

WHEREAS, the Committee convened on August 17, 2022 and deliberated the results of their Post Qualification. It was found that all the documents submitted by Engr. Pocholo R. Trinidad of Parasat and Mr. Anthony Khass R. Navales of PLDT were genuine, authentic and responsive;


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) recommend for approval the extended period of post-qualification activities, that is, from August 15, 2022 to August 17, 2022 as per Section 34.8 of the Revised IRR of R.A. No. 9184;
- b) declare the bids of *Parasat Cable TV, Inc. for Item No. 1 and PLDT, Inc. for Item No. 3* as the Lowest Calculated and Responsive Bids (LCRB) of the *Proposed Procurement for the Supply, Delivery, Installation and Commissioning of WAN Dark Fiber Rental and Internet Connectivity for USTP*;
- c) recommend the award of the contract to *Parasat Cable TV, Inc. for Item No. 1* in the total amount of **FOUR MILLION THREE HUNDRED EIGHT THOUSAND PESOS AND 00/100 (P4,308,000.00) ONLY**; and
- d) recommend the award of the contract to *PLDT, Inc. for Item No. 3* in the total amount of **FOUR HUNDRED TWENTY-THREE THOUSAND THREE HUNDRED SIXTY PESOS AND 00/100 (P423,360.00) ONLY**.
