BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO SMART COMMUNICATIONS, INC. OF THE PROPOSED PROCUREMENT FOR THE SUPPLY AND DELIVERY FOR LOT 1 AND LOT 2 AND SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING FOR LOT 3 OF DATA CONNECTIVITY TO SUPPORT FLEXIBLE LEARNING PROGRAM IN THE AMOUNT OF P1,050,000.00 FOR LOT 1.1 AND P3.840,000.00 FOR LOT 2

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for Proposed Procurement for the Supply and Delivery for Lot 1 and Lot 2 and Supply, Delivery, Installation and Commissioning for Lot 3 of Data Connectivity to Support Flexible Learning Program, in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of NINE MILLION TWO HUNDRED FORTY THOUSAND PESOS AND 00/100 (P9,240,000.00) ONLY; Lot 1 - Electronic Load (P4,200,000.00), Lot 2 - Internet Subscription Data Plan (P3,840,000.00) and Lot 3 – Internet Connection (P1,200,000.00);

WHEREAS, in response to the said advertisement, three (3) prospective bidders acquired the bidding documents, namely: Smart Communications, Inc. (Smart) for Lot 1 & Lot 2, Globe Telecom, Inc. (Globe) for Lot 1, and Parasat Cable TV, Inc. (Parasat) for Lot 3;

WHEREAS, during the deadline and submission of bids on June 22, 2021, 10:00 A.M., the same prospective bidder submitted their bid proposals;

WHEREAS, the Committee opened the first envelopes of the following prospective bidders in chronological order:

WHEREAS, Globe was rated "failed" due to the following ground: Tax Clearance is expired;

WHEREAS, Smart was rated "passed" in the preliminary examination of its legal, technical and financial documents:

WHEREAS, Parasat was rated "failed" due to the following grounds: Tax Clearance is expired, SLCC is not supported with user's acceptance or official receipt(s) or sales invoice issued for the contract and Non-submission of the Secretary Certificate for authority to sign the bidding documents;

WHEREAS, the Committee informed Globe and Parasat that they may submit a letter-request for reconsideration within three (3) calendar days;

WHEREAS, the Committee then opened the second envelope of Smart;

WHEREAS, Smart made a bid of Lot 1.1 - P1,050,000.00 and Lot 2 - P3,840,000.00;

WHEREAS, the Committee considered the bids of Smart for evaluation;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the Technical Working Group (TWG), on June 24, 2021, 01:00 P.M. on the bid of Smart. The Committee found no arithmetical correction in the financial bid of Smart. The amount of bid as read was the same as calculated;

WHEREAS, the Technical Representative and TWG submitted a Technical Report dated June 24, 2021;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Smart to be complying and declared Smart as the SCB at the amount of P4,890,000.00;

WHEREAS, the Committee conducted post-qualification of Smart on July 05, 2021;

WHEREAS, the Committee convened and deliberated the results of their Post Qualification on the same day. It was found that all the documents submitted by Mr. Anthony Khass Navales of Smart. was genuine, authentic, and responsive;

NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of Smart Communications, Inc. as Single Calculated and Responsive Bid (SCRB) for the Proposed Procurement for the Supply and Delivery for Lot 1 and Lot 2 and Supply, Delivery, Installation and Commissioning for Lot 3 of Data Connectivity to Support Flexible Learning Program; and
- b) recommend the award of the contract in the total amount of ONE MILLION FIFTY THOUSAND PESOS AND 00/100 (P1,050,000.00) ONLY for Lot 1.1 and THREE MILLION EIGHT HUNDRED FORTY THOUSAND PESOS AND 00/100 (P3,840,000.00) ONLY for Lot 2.
