# Proposed Construction of Student Study Shed 3 at USTP-CDO Campus CY 2023

### **CONTRACT AGREEMENT**

THIS AGREEMENT, made this <u>7<sup>th</sup></u> day of <u>May</u>, <u>2024</u> between *University of Science and Technology of Southern Philippines (USTP) – CDO Campus, with office address at C.M. Recto Ave., Lapasan, Cagayan de Oro City* (hereinafter called the "Entity") and *JDE Construction, Zone 8, Brgy. Poblacion El Salvador, Misamis Oriental* (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute *Proposed Construction of Student Study Shed 3 at USTP-CDO Campus CY 2023 (Contract No. USTP-IFPB-10-2023-2278-3655)* (hereinafter called "the Works") and the Entity has accepted the Bid for *FOUR MILLION THREE HUNDRED THIRTEEN THOUSAND SIX HUNDRED FOURTEEN PESOS AND 92/100 (P4,313,614.92) ONLY* with C.A. No. 24-05-0147 by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz*.:
  - a. Philippine Bidding Documents (PBDs);
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Bill of Quantities:
    - iv. General and Special Conditions of Contract;
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

c. Performance Security;

- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed. Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of FOUR MILLION THREE HUNDRED THIRTEEN THOUSAND SIX HUNDRED FOURTEEN PESOS AND 92/100 (P4,313,614.92) ONLY or such other sums as may be ascertained JDE Construction agrees to Proposed Construction of Student Study Shed 3 at USTP-CDO Campus CY 2023 in accordance with his/her/its Bid.
- 4. The *USTP-CDO* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
