BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PARASAT CABLE TV, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF REDUNDANT 3GBPS FIBER INTERNET CONNECTION FOR USTP-CDO CAMPUS CY 2026 IN THE AMOUNT OF ₱2,751,000.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Redundant 3Gbps Fiber Internet Connection for USTP-CDO Campus CY 2026* in PhilGEPS, University website, and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of THREE MILLION EIGHTEEN THOUSAND EIGHT HUNDRED NINETEEN PESOS AND 96/100 (₱3,018,819.96) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: Parasat Cable TV, Inc. (Parasat);

WHEREAS, on the deadline for submission of bids last July 06, 2026, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the First Bid Envelope of the lone bidder;

WHEREAS, Parasat was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the Second Bid Envelope of Parasat;

WHEREAS, Parasat made a bid of ₱2,751,000.00;

WHEREAS, the Committee considered the bid of Parasat for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated July 08, 2026;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last July 08, 2026, 10:00 A.M. on the bid of Parasat. The Committee made no arithmetical correction in the financial bid of Parasat, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of Parasat to be complying and declared the bid of Parasat as the Single Calculated Bid (SCB) at the amount of ₱2,751,000.00;

WHEREAS, the Committee conducted an onsite post-qualification of Parasat at their branch office in Limketkai Center, Rosario Cres, Cagayan de Oro City last July 14, 2026;

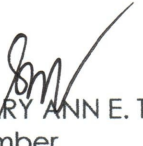
NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:
