

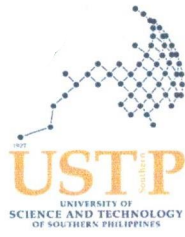

BAC RESOLUTION DECLARING LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING AWARD TO TOYOTA CAGAYAN DE ORO, INC. OF THE SECOND RE-BIDDING FOR THE PROPOSED PROCUREMENT OF THE SUPPLY AND DELIVERY OF MOTOR VEHICLE FOR OFFICE OF THE PRESIDENT CY 2025 IN THE AMOUNT OF P2,367,328.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid of the *Second Re-bidding for the Proposed Procurement of the Supply and Delivery of Motor Vehicle for Office of the President CY 2025 in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of TWO MILLION FIVE HUNDRED THOUSAND PESOS AND 00/100 (P2,500,000.00) ONLY*;

WHEREAS, in response to the said advertisement, two (2) prospective bidders acquired the bidding documents namely: North-Min Auto Dealership, Inc. (Isuzu) and Toyota Cagayan de Oro, Inc. (Toyota);

WHEREAS, on the deadline of submission of bids last November 17, 2025, 09:30 A.M., the same prospective bidders submitted their bid proposals;

WHEREAS, the Committee opened the first envelope of the prospective bidders in the order of their submission;

WHEREAS, Isuzu and Toyota were rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, the Committee then opened the second envelope of Isuzu and Toyota;

WHEREAS, Isuzu made a bid of P2,448,000.00;

WHEREAS, Toyota made a bid of P2,367,328.00;

WHEREAS, the Committee considered the bid of Isuzu and Toyota for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated November 19, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, on November 19, 2025, 02:00 P.M. on the bids of Isuzu and Toyota. The Committee made no arithmetical correction in the financial bids of Isuzu and Toyota, the total amount of bids as read were the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bids of Isuzu and Toyota to be complying and declared the bid of Toyota as the Lowest Calculated Bid (LCB) in the amount of P2,367,328.00;



NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:

- a) declare the bid of *Toyota Cagayan de Oro, Inc.* as the Lowest Calculated and Responsive Bid (LCRB) of the *Second Re-bidding for the Proposed Procurement of the Supply and Delivery of Motor Vehicle for Office of the President CY 2025*; and
- b) recommend the award of the contract in the total amount of **TWO MILLION THREE HUNDRED SIXTY-SEVEN THOUSAND THREE HUNDRED TWENTY-EIGHT PESOS AND 00/100 (P2,367,328.00) ONLY.**


