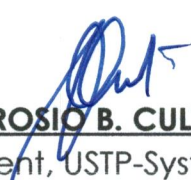

BAC RESOLUTION DECLARING SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING AWARD TO PLDT, INC. FOR THE PROPOSED PROCUREMENT OF THE SUPPLY, DELIVERY, INSTALLATION AND COMMISSIONING OF INTERNET CONNECTIVITY FOR USTP-PANAON CAMPUS CY 2025 IN THE AMOUNT OF P1,000,200.00

WHEREAS, the UNIVERSITY OF SCIENCE AND TECHNOLOGY OF SOUTHERN PHILIPPINES advertised the Invitation to Bid for the *Proposed Procurement of the Supply, Delivery, Installation and Commissioning of Internet Connectivity For USTP-Panaon Campus CY 2025* in PhilGEPS, University website and in conspicuous place at the premises of the University with an Approved Budget for the Contract (ABC) of ONE MILLION TWO HUNDRED PESOS AND 00/100 (P1,000,200.00) ONLY;

WHEREAS, in response to the said advertisement, only one (1) prospective bidder acquired the bidding documents, namely: PLDT, Inc. (PLDT);

WHEREAS, on the deadline for submission of bids last September 22, 2025, 09:30 A.M., the same prospective bidder submitted its bid proposal;

WHEREAS, the Committee opened the first envelope of the lone bidder;

WHEREAS, PLDT was rated "passed" in the preliminary examination of its legal, technical and financial documents;

WHEREAS, PLDT made a bid of P1,000,200.00;

WHEREAS, the Committee considered the bid of PLDT for evaluation;

WHEREAS, the Technical Representative and Technical Working Group (TWG) submitted a Technical Report dated September 26, 2025;

WHEREAS, the Detailed Bid Evaluation was conducted by the Committee, with the assistance of the TWG, last September 26, 2025 10:00 A.M. on the bid of PLDT. The Committee made no arithmetical correction in the financial bid of PLDT, the amount of bid as read was the same as calculated;

WHEREAS, the Committee, with the assistance of the TWG, after scrutiny, careful evaluation and deliberation, found the bid of PLDT to be complying and declared the bid of PLDT as the Single Calculated Bid (SCB) at the amount of P1,000,200.00;

WHEREAS, the Committee conducted an online post-qualification of PLDT at their main office in Ramon Cojuangco Building, Makati Avenue, Makati City, Metro Manila last October 03, 2025.

WHEREAS, the Committee convened and deliberated the results of their Post-Qualification on October 08, 2025. It was found that all the documents submitted by Mr. Anthony Khass R. Navales of PLDT were genuine, authentic and responsive;

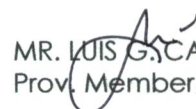


NOW, THEREFORE, the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED, to:
